#### **CHAPTER 832: LIVE ENTERTAINMENT**

### § 832.01 LIVE ENTERTAINMENT DEFINED.

As used in this chapter, *LIVE ENTERTAINMENT* means the use of an orchestra, band, individual or group who or which entertains others at an establishment by singing, dancing, playing music or in any other manner.

## § 832.02 LICENSE REQUIRED.

No owner or operator of any saloon, bar, club, legion, lodge or other establishment, which is open to the public, shall use or present live entertainment of any kind, in such establishment, without first obtaining a license therefore from the Village Administrator.

### § 832.03 LICENSE FEES.

An applicant for the license required by § 832.02 shall pay a fee of \$50 to the Village Administrator for a license for each exhibition of live entertainment in the village. Such license shall be good for one 24-hour period as stated on the license.

# § 832.04 LICENSE ISSUANCE AND REVOCATION.

The Village Administrator or the Chief of Police may deny the issuance of a license for good cause and may revoke or suspend a license at any time during the period for which it is valid, due to numerous complaints, disorder, fighting, brawling, excessive noise, persons of bad character or ill repute frequenting the licensed establishment, gambling or any situation not in the best interest of the public affected.

# § 832.05 INTERPRETATION.

Nothing in this chapter is intended to be in conflict with or supersede any state law governing the licensing of an establishment for entertainment.

#### § 832.99 PENALTY.

Whoever violates any of the provisions of this chapter is guilty of a minor misdemeanor and shall be fined not more than \$500 for each offense. A separate offense shall be deemed committed each day during or on which a violation occurs or continues.
